NOTIFICATION UNDER SECTION 5 OF THE RIGHT TO  
INFORMATION (CENTRAL) ACT, 2005 (No. 22 OF 2005)

In modification of Notification of even number dated 20/02/2007, the following notification is passed.

It is hereby notified to the general public that for furnishing information under the Right to Information Act, 2005 (Central Act No.22 of 2005) (hereinafter referred to as 'the Act' the 'Deputy Registrar (Admn.), Karnataka Lokayukta, M.S.building, Bangalore-1', is designated as the "State Public Information Officer" in regard to the Head Office of the Karnataka Lokayukta, M.S.building, Bangalore-1 and 'the Superintendent of Police-1 in the office of Karnataka Lokayukta, M.S.building, Bangalore-1 is designated as "Asst. State Public Information Officer" in regard to the Head Office of the Karnataka Lokayukta, M.S.building, Bangalore-1 to whom applications under Section 5(1) of the Act shall be given and they shall deal with those applications in accordance with the provisions of the Act.

It is further notified to general public that for furnishing information under the Right to Information Act, 2005 (Central Act No.22 of 2005) (hereinafter referred to as 'the Act') the 'Superintendent of Police', Karnataka Lokayukta of concerned districts under their jurisdiction, is designated as the "State Public Information Officer" and 'Deputy Superintendent of Police of Karnataka Lokayukta of concerned districts under their jurisdiction and the Inspectors of Police of Karnataka Lokayukta of concerned districts under their jurisdiction', are designated as "Asst. State

*Public Information Officers*” at District Level, to whom applications under Section 5(1) of the Act shall be given and they shall deal with those applications in accordance with the provisions of the Act.

In the event of refusal to give the information sought by a public, such of the applicant is entitled to make an appeal to the Registrar, Karnataka Lokayukta, Bangalore, under Section 19 of the said Act within the prescribed period. Therefore, the ‘Registrar, Karnataka Lokayukta’, is designated as the “Appellate Authority” as provided under Section 19 of the said Act.
